and Traffic Violations:

Parking Ticket: Issued for parking violations, containing details like date, time, license plate, vehicle make/model, location, and fine.

Faculty/Staff Parking: Lot C-Employee Lot and Employee spaces.

Parking Spaces: Vehicles must be parked within lined spaces, not in traffic lanes or outside designated areas. No unauthorized vehicle driving on grounds or sidewalks.

Handicapped Parking: Requires a valid Disabled Parking Placard or license plate.

Pregnancy Parking Accommodation: Temporary permits available for expectant mothers.

Fire Lanes/Hydrants: No parking in fire lanes or within 15 feet of hydrants.

Temporary Closures: Parking lots may be closed for special events or emergencies. **Traffic/Moving Violations**: Issued for speeding violations and stop sign violations.

The campus speed limit is 20 mph. Speeding violations are subject to fines.

Fines and Penalties:

Appeals:

Tickets must be appealed within 5 days of issuance. An appeal form can be obtained from the Campus Security Office, Room C2177 or online on our website. The Director of Campus Safety and Security will have 10 days to determine whether the ticket stands or is dismissed. The Director will then make notification to the appellant of the final decision.

If the ticket is upheld, the appellant must pay the fine. The appellant will have an additional 15 days upon written notification to pay for the ticket.
